Das **Bundesamt für das Personalmanagement der Bundeswehr (BAPersBw)** ist eine Bundesoberbehörde, welche im Rahmen der Neuausrichtung der Bundeswehr geschaffen wurde. Sie ist für die Personalführung der Soldaten und Beamten bis einschließlich Besoldungsgruppe A16 sowie des Tarifpersonals ab Entgeltgruppe 9 sowie die militärische und zivile Personalgewinnung zuständig. Diese Aufgaben wurden davor vom Bundesamt für Wehrtechnik und Beschaffung (BWB), dem Bundesamt für Wehrverwaltung (BAWV), den Wehrbereichsverwaltungen (WBV), der Stammdienststelle der Bundeswehr (SDBw) und dem Personalamt der Bundeswehr (PersABw) erfüllt. Das BAPersBw wurde zum 1. Dezember 2012 eingerichtet.

Die feierliche Indienststellung mit Enthüllung des neuen Wappens fand am 3. Dezember 2012 in der Lüttich-Kaserne in Köln statt. Präsident des 3000 Dienstposten umfassenden Bundesamtes wurde der frühere Präsident der Wehrbereichsverwaltung West, Georg Stuke, Vizepräsident wurde der frühere Leiter der SDBw, Generalmajor Manfred Hofmann, Geschäftsführender General ist seitdem Brigadegeneral Jürgen Knappe.<sup>[1]</sup>

Die ministerielle Dienst- und Fachaufsicht über das BAPersBw wird durch die Abteilung Personal des Bundesministeriums für Verteidigung ausgeübt.

- Abteilung V Personalführung Zivilpersonal (Standort: Sankt Augustin), Erste Direktorin Sabine Grohmann
- Abteilung VI Personalführung Reservisten (Standort: Brückberg-Kaserne in Siegburg), Oberst Rolf Gaus

„Im Bereich Personalgewinnung innerhalb dieses Bundesamtes werden die bisherigen Aufgaben der Kreiswehrrersatzämter und der zivilen und militärischen Nachwuchsgewinnungsorganisationen zusammengeführt. Um eine umfassende Information von Interessenten über alle zivilen und militärischen Berufsbilder der Bundeswehr zu gewährleisten, werden 110 ständig besetzte und bis zu 200 mobile Karriereberatungsbüros eingerichtet. Neben diesen Elementen in der Fläche werden 16 Karrierecenter der Bundeswehr mit einem umfassenden Beratungs- und Informationsangebot für Politik, Behörden und Wirtschaft geschaffen.“<sup>[2]</sup>

## 0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document “free” in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially. Secondly, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.
